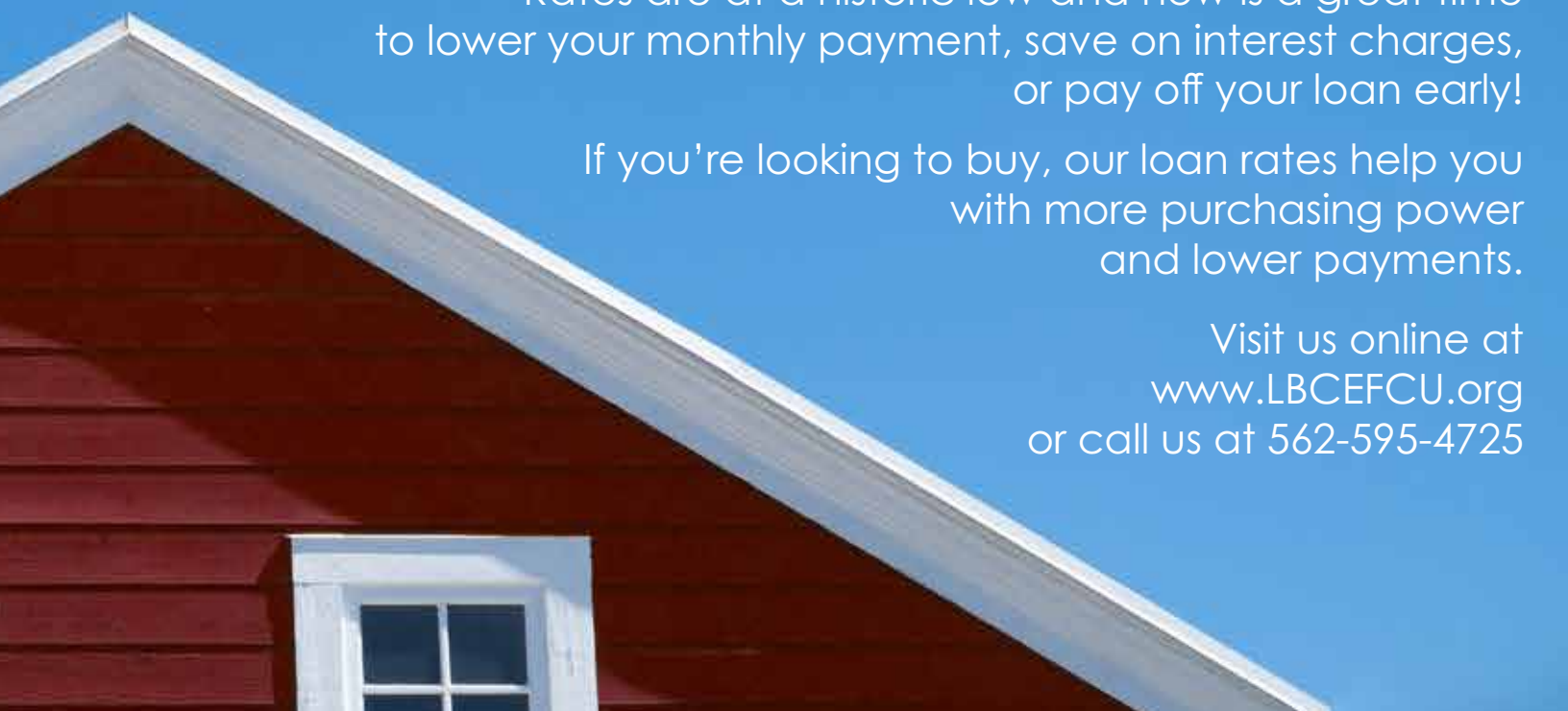

HOW THE CREDIT UNION IS PROTECTING OUR MEMBERS AND EMPLOYEES DURING THE COVID-19 OUTBREAK

Protecting our members and employees during the Coronavirus/COVID-19 outbreak is the Credit Union's first priority. The Credit Union continues to monitor the Centers for Disease Control (CDC) guidelines to appropriately respond to this public health threat.

WHAT THE CREDIT UNION IS DOING TO PROTECT OUR MEMBERS AND EMPLOYEES

We are disinfecting high touch areas, including teller counters, the ATM and other surfaces many times per day.

We are providing hand sanitizer and have placed 6 foot markers at the teller line.

We have educated our employees about best practices to prevent the spread of the virus and other illnesses.

We have limited to 6 the number of members who may be in the branch at any given time and have limited guests to only those necessary for a member to transact business.

We have limited meetings and other public events and have established procedures for any employee with symptoms of illness.
